performance levels:

**basic requirements for safety footwear (SB)** (see Table 2 and 3 of EN ISO 20345:2011): all mandatory ones, among which:

**SRC (\*) = Slip resistance** – meets the following requirement:

- surface: ceramic / lubricant: detergent solution;
- surface: steel / lubricant: glycerol.

(\*) the final level of the anti-slip features is achieved after the first hours of trial stage.

**Additional requirements** (Tab. 18 and 20 of EN ISO 20345:2011):

**S1** = closed seat region, antistatic properties, energy absorption of seat region, resistance to fuel oil.

Marking:

on a stitched label and displaying the following information:

- **CE Marking**;
- Name/Trademark of the Manufacturer;
- designation of the footwear (unique/unambiguous);
- Standard of reference + safety symbols;
- size of footwear (printed onto the outsole);
- date of production.



NOTE: the Technical File contains a more detailed description of the PPE (material, method of assembly, photographs or drawings), performance data, safety functions and level of protection, elements of conformity to the basic and supplementary requirements. The Technical File is integral part of the present Certification, which has to be kept available by the applicant to be forwarded - upon request - to the entitled person (supervising body, Controlling Officer).
