Functions and performance levels: **basic requirements for safety footwear (SB)** (see Table 2 and 3 of EN ISO 20345:2022): all mandatory ones, among which:

Slip resistance = slip resistance on ceramic tile floor with NaLS.

Additional requirements (Tab. 16 and 20 of EN ISO 20345:2022):

S3 = closed heel area, energy absorption of seat region, antistatic properties, water penetration and absorption, perforation resistance: Type P, cleated outsole; **FO** = resistance to fuel oil; **AN** = ankle protection; **SR^(*)** = slip resistance on ceramic tile floor with glycerine.

Note: (*) the final level of the anti-slip features is achieved after the first hours of trial stage.

Marking: on a stitched label and displaying the following information:

- **CE Marking**;
- Name/Trademark of the Manufacturer + complete address;
- designation of the footwear (alphanumeric code);
- nr. and year of the Standard of reference + safety symbols;
- size of footwear (printed onto the outsole);
- date of production.



NOTE: the Technical File contains a more detailed description of the PPE (material, method of assembly, photographs or drawings), performance data, safety functions and level of protection, elements of conformity to the basic and supplementary requirements. The Technical File is integral part of the present Certification, which has to be kept available by the applicant to be forwarded - upon request - to the entitled person (supervising body, Controlling Officer).
